SWT Council priorities

Key Messages this week

1. SWT launches Community Chest

SWT has launched a new fund to help communities recover from the effects of COVID-19. The Community Chest of £250,000 is now open to support one-off initiatives run by the voluntary and community sector, and wider community groups who have been unable to secure mainstream funding from the Council or other sources.

Grants of up to £7,500 can be awarded to supplement activities and projects, covering up to 75% of the total cost with applicants needing to find at least 25% from their own or other sources.

The Community Chest Scheme will give consideration to initiatives that will help community groups become sustainable in the longer term; that will help the community to recover from the effects of COVID-19; and are aligned to SWT's

corporate priorities of housing and communities, the environment and the economy.

3. SWT declares ecological emergency

Somerset West and Taunton Council has declared an ecological emergency complementing the climate emergency declaration made in February 2019.

A meeting of the Full Council unanimously supported a motion which gives equal importance to ecological issues alongside climate emergency actions.

The motion recognised that societies and economies are intimately linked with and depend on biodiversity and nature, and that steps need to be taken to protect and enhance our natural habitats.

SWT will now seek to address ecological issues alongside climate emergency actions, maximising opportunities from combining both the climate and ecological emergencies together.

It will manage Council services, buildings and land in a biodiversity-friendly manner; embed ecological initiatives alongside climate action in all work areas; and ensure that addressing both emergencies are strategic priorities for planning policies and design guides for new development.

4. SWT encourages residents to go green

SWT is encouraging homeowners and private landlords to apply for a Green Homes Grant in line with its corporate priorities for climate change and housing.

The Government's Green Homes Grant scheme will allow Somerset West and Taunton residents to make home improvements helping to save up to £600 a year on their energy bills. It will fund up to two-thirds of the cost of works with grants available for up to £5,000. Low income households are eligible to receive 100% government funding up to a maximum of £10,000.

5. SWT adopts affordable employment land policy

SWT is making it easier for small businesses to set up or expand in rural areas across the district. Full Council this week approved the adoption of a Local Development Order (LDO) which will support the delivery of small scale industrial and employment space in rural areas in line with its Corporate Strategy

objective to ensure the provision of adequate and affordable employment land to meet different business needs.

The affordable employment land LDO will allow independent entrepreneurs and small business to create or expand their businesses outside of SWT's established centres for employment without the administrative costs and burdens of a full planning application.

It was developed in response to demand from small businesses to set up or expand their existing operations but has become increasingly significant as the Council works to promote economic recovery from COVID-19.

6. Free Trees Reminder

SWT is offering parish and town councils across the district free trees as part of its commitment to work towards carbon neutrality and climate resilience by 2030.

Councils can choose from Oak, Beech, Lime and Hawthorn bare root trees to the value of £50 to be collected from one of three locations across the district – Taunton Deane Nurseries, Wellington Depot or Minehead Depot.

7. How to Report Fly-tipping

Fly-tipping – dumping rubbish - is an environmental crime. It's a blot on our landscape and a threat to wildlife. We can all fight fly-tipping by reporting dumped rubbish and, if possible, who dumped it. Everyone, including businesses, must be responsible for how they get rid of rubbish, even when it's left your home or premises.

If you pay someone to remove your rubbish - man-with-a-van, builders, gardeners, carpet-layers or others - ask to see their waste carrier's licence, and make sure you know where your rubbish will go. How to report fly-tipping:

- To report flytipping use SWT [report fly-tipping](#) online form or phone **0300 304 8000**
- make sure you give the exact spot. If you don't know the address include a description of nearest landmark in your report
- take a photograph if you can and include it in your report. SWT will attend to reported fly-tipping incidents within 5 working days.

Partner Engagement – Key messages from other Public Service Areas

Somerset County Council (SCC)

Highway Maintenance Update

SCC Highways are currently focusing on the routine tasks of gully emptying, safety defect repairs and patching. In recent weeks SCC Highways has reported on the preparatory work for the 2021 carriageway surface dressing programme. Most road running surfaces today are dressings, a process that evolved in the early part of the 20th century. Prior to then, roads were either cobbled or made of pitched large stones with a fine, gritty topping. They were muddy in winter and could be dusty in dry weather. This became a particular problem with the introduction of the motor car. Initially tar was used to keep the dust down and later chippings were added on top to protect the tar layer and improve skid resistance.

As time progressed, experience and science informed new developments which resulted in the modern surface dressings of today. Modified bitumen emulsions from the oil industry have replaced coal tar, a by-product of "town gas" production. Different sizes and grading of chippings, and combinations of both materials, have evolved to address different road conditions. Factors that are taken into account when designing a dressing are the volume of traffic, especially heavy vehicles; road gradient and curvature; junctions and other high stress features; tree cover; and climate. The design process allows for the fact that conditions are much different in Somerset than they are in, say, Lancashire!

Armed with site measurements, observations and data, the design process takes place during the winter so that orders can be placed for bitumen emulsion binder and chippings in time for the summer programme.

Temporary Road Closure – Viney Street, Taunton

To enable Wessex Water to carry out supply separation works, Viney Street, Taunton will be closed for a distance of approximately 50 metres. The [Order](#) becomes effective

on **15 October 2020** and will remain in force for eighteen months. The works are expected to commence on the 19 October and last until 23 October 2020 between the hours of (00:00 – 23:59) for a total of five days.

Somerset parents are being urged to apply for school places online and in time. Whether your child is starting school for the first time, or transferring to their next school, applications need to be made through [Somerset County Council's website](#). The deadline for parents to submit applications for secondary school places is **Saturday 31 October 2020**. This applies to all children moving from primary to secondary school, or middle to upper school, in September 2021.

The deadline for primary school place submissions is Friday 15 January 2021. This applies to all children starting school for the first time in September 2021, as well as those moving between infant and junior or first and middle school.

Somerset Library Service

Libraries offer digital help for job seekers

Somerset Libraries are kicking off National Libraries Week with an innovative new scheme. From **Monday 5 October** iPads will be available to job seekers looking for an extra bit of help in their quest for employment.

The free iPad Loan Scheme from SCC is designed to help people looking for a new job or career but who may not have the IT skills or equipment they need.

Members of Somerset Libraries can borrow a device for up to six weeks free of charge from Bridgwater, Chard, Minehead, Shepton Mallet or Taunton libraries.

The tablets are pre-loaded with links, information and support for anyone in Somerset currently looking for employment, or who think they may need to be looking soon. The iPads are data-enabled, meaning people do not need to have internet access at home to use them.

There's a simple step-by-step 'How to Use' video on using the iPad and information including how to develop an effective CV, tips for successful interviews, how to search for local jobs and some useful health and wellbeing information and links.

Additional free one-to-one support is available from the Positive People Programme, including a 24/7 helpline, digital support, virtual job clubs and workshops.

National Fire Chiefs Council

Home Safety Week 28 September to 4 October 2020

This week is Home Safety Week and the National Fire Chiefs Council (NFCC) are encouraging people to assess the needs of their homes and ensure they have adequate alarm systems.

In 20% of accidental dwelling fires in the UK smoke alarms fail to activate. The most common reason was because the fire was outside the alarm's range. So, the NFCC is asking householders to install alarms to ensure the whole home is covered. Smoke alarms should be installed in the rooms used most, this is where a fire is most likely to start. The NFCC would also like consistent legislation for the fitting of detection in the UK. All homes in the UK should be equally protected by adequate detection regardless of tenure or location.

See below for some home safety tips:

- Install at least one smoke alarm on each level of your home and also in the rooms you use most
- Carbon monoxide alarms should be installed in all rooms where there is fuel burning appliance
- Test all alarms regularly to make sure they work
- Ensure all appliances are installed and maintained correctly by registered and suitably qualified tradespeople
- Alarms don't last forever, replace them at least every 10 years
- If you can, interlink alarms

As well as expert advice, some businesses also offer telescopes, guide books and other equipment, and these are also available to rent and buy from National Park Centres in Lynmouth, Dunster and Dulverton.

In light of the coronavirus update, ENP has reviewed the most recent government guidance and are happy that some events can still go ahead, although all events must be pre-booked with the relevant event organiser.

Wessex Water Recovery Fund offers support to COVID-hit communities

Wessex Water is providing more financial help for community groups in response to the ongoing coronavirus pandemic. The Wessex Water Recovery Fund aims to strengthen communities following the COVID-19 outbreak, with an emphasis on local rather than national projects. The fund will be available to charities and community groups across Somerset from the 5 October and will close on 4 December with decisions made at local community panels in January 2021.

The fund is part of the new Wessex Water Foundation, a multi-million pound initiative which was launched in June and provides a dedicated funding stream for charitable and community projects across the Wessex Water region.

It is run in partnership with the [Somerset Community Foundation](#) and has already been prioritising those worst affected by the coronavirus pandemic.

Particular priority will be given to those groups that are working to:

- support people in financially difficult circumstances
- help build stronger communities
- support the green recovery with new initiatives
- restore and protect nature and wildlife for community health and wellbeing.

From April 2021 the Wessex Water Foundation plans to provide at least half a million pounds of funding every year to support community projects, local environment projects, debt advice and charities helping those who are suffering the consequences of poverty through low income or unemployment.

Voluntary and Community Sector Support

Grants from The Somerset Fund to help local charities thanks to generous local businesses

If you are a grassroots community group based in Somerset, grants are available up to the value of £2,500 from **The Somerset Fund**. Somerset Community Foundation (SCF) manages the Fund and is encouraging applications from smaller charities and community groups that run on less than £100,000 per year.

The grants will be ‘unrestricted’, which means they can be used to pay for ongoing running costs, also known as ‘core costs’. Applications to the Fund through SCF’s website and the next **deadline to apply is Friday 16 October 2020**.

Lendology CIC (Community Interest Company)

Lendology CIC is a trading name of Wessex Resolutions CIC. Based on the outskirts of Taunton, the team works across the South West providing a variety of loan schemes in partnership with local district Councils. Starting in 2003, the organisation created a partnership with ten local councils to provide loans to eligible homeowners to fund essential home repairs, improvements or adaptations. This was when the central government was encouraging local councils to create sustainable schemes for homeowners and reduce the reliance on grant funding.

As a not-for-profit organisation, using the Council partner funding, Lendology CIC are able to provide homeowners access to financial support to help with the cost of repairs.

The scope of the scheme has been developed in line with individual council housing policies. A range of loan schemes are available to cater to the needs of varying audiences including homeowners, park homeowners, landlords, empty property owners and first-time buyers.

Home-Start West Somerset

Home-Start schemes are rooted in the communities they serve and managed locally. They are supported by the national organisation. This offers direction, training, information and guidance to schemes as well as a robust quality assurance programme in which Home-Start West Somerset received an outstanding 100% result in 2013.

There is [no central funding](#) available from the national body so the local scheme has to raise all of its own funds. This creates a significant challenge for the team.

Home-Start West Somerset works with families from Minehead, Dunster, Porlock, Dulverton and Watchet right through to Stogursey and everywhere in between. They offer support, friendship and practical support to parents with young children in their local community. The Annual Report has just been produced and is attached in PDF format. Good Neighbours Scheme Launched in North Taunton

Communities in the North Town area of Taunton, who have come together this year to offer a lifeline to those in need during this coronavirus pandemic, are the latest group to join the Somerset Good Neighbours Scheme.

Good Neighbours Schemes are community projects run by local groups of volunteers to help those who are frail, elderly, disabled, vulnerable or isolated to enjoy a better quality of life. Help is given free of charge with simple tasks such as shopping, collecting prescriptions, attending hospital appointments, dog walking, gardening as well as the opportunity for a regular friendly chat.

During lockdown, North Town Community Support offered a lifeline to over 150 people, not just in practical terms with shopping and prescriptions, but also by helping to reduce isolation and loneliness. The whole community has benefitted, with lots of new friendships made and everyone has the reassurance of knowing they can access help, should they need it.

Volunteering gave people a positive purpose too. Some of those who couldn't get out and about or help physically made a massive contribution in other ways with things like sharing food and sewing masks.

In September this year, the group joined the Somerset Good Neighbours Scheme, making it part of a supportive network with access to peer support and advice on best practice.

Download the new NHS Test and Trace app now

The NHS [COVID-19 app](#) has launched in England and Wales, including QR check-in at venues. You can now download the app and help control the spread of coronavirus and protect yourself and your loved ones as case numbers rise.

It is available to anyone aged 16 and over in multiple languages and forms a central part of the NHS Test and Trace – identifying contacts of those who have tested positive for coronavirus.

The contact tracing element of the app works by using low-energy Bluetooth to log the amount of time you spend near other app users, and the distance between you, so it can alert you if someone you have been close to later tests positive for COVID-19 – even if you don't know each other.

The app will advise you to self-isolate if you have been in close contact with a confirmed case. It will also enable you to check symptoms, book a free test if needed and get your test results.

FAQS

- Q. My child has been sent home from school to self-isolate for 14 days as a child in their class / year group has tested positive for coronavirus. What are the top tips to help me manage this situation?**
- A.** It is important that families remain alert and take care to avoid the spread of infection. You will need to discuss as a family how you will manage your time at home and what this means for your child/young person. Try not to feel overwhelmed to do lots every day, keep it simple and use this time to build on your relationship together. Provide structure to each day - setting a plan for each day can support children and young people to know what to expect as well as help to keep a positive routine. Set breaks throughout the day for free choice time when your child or young person can connect with other young people

using a form of social media, online. [Click here](#) to read more about how you can manage your child's / young persons' time out of school.

- Q. How will the new rules on gatherings of more than 6 people be enforced?**
- A.** The police will be able to enforce the legal limits, and if you break them you could face a fine (fixed penalty notice) of £200, doubling for further breaches up to a maximum of £6,400. Hospitality businesses are also required to ensure there are no unlawful gatherings in their premises that should also be COVID-19 secure. Breaches will be enforced. Any breaches are liable of a fine of up to £10,000. From 28 September the Government extended these legal requirements to extra businesses in the leisure and entertainment sectors. Anyone holding a gathering of more than 30 (such as a rave or house party) could face a £10,000 fine.
